As you notice I am proposing Dr. Israel Glazer for the position of Second Vice President and I am glad to know that many others have proposed him for the Executive Committee.


Dr. Israel Glazer (Israel), 53 years old, is one of the leading allergists in this country and serves as head of the allergy clinic at the Sheba Medical Center Tel-Hashomer, which is the largest hospital in Israel. He was elected President of the Israel Society of Allergology in 1970 and for a second two-year's term in 1972. Since 1952 he is an Affiliate Fellow of the American Academy of Allergy.

Dr. Glazer has been very active in the I.A.A. affairs, served on many of its Committees including the Executive Committee and attended most of the I.A.A. Congresses. He is a Member of the Council of the Collegium Internationale Allergologicum and a contributing editor of the International Archive of Allergy and Applied Immunology. Dr. Glazer published many papers on basic and clinical aspects of allergology and is a member of the Post Graduate Medical Faculty of the Tel-Aviv University.

His experience in organizing international congresses ~~and~~ <sup>a</sup> symposium in Israel will prove an asset, since we are planning to invite the 1979 I.A.A. Congress to Israel. Multilingual.

I hope that we will finally come up with a well balanced proposition which will be acceptable by the House of Delegates.
