Dear Colleague:

The American College of Allergists invites you to attend the first International Food Allergy Symposium to be held in Toronto, Canada, October 10-15, 1976, at the Four Seasons Sheraton Hotel. This distinctive hotel is a city within itself, where your committee has arranged a convention package to allow you to enjoy dining, dancing, shopping, movie theaters and a $2\frac{1}{2}$ acre park with a breathtaking waterfall.

Toronto was selected for this symposium because of its exceptional medical, educational facilities for post graduate training. This medical community has been most cooperative in extending hospitality and friendly assistance to insure the success of our meeting.

The principal goals of this symposium are improved care for our patients and aid in preparation for future ABAI examinations. A most distinguished faculty has been chosen to present the subject matter.

Continuing medical education credit becomes increasingly important as the close of 1976 approaches. This symposium is approved for twenty-five hours of Category I credit, which may be sufficient to satisfy your CME requirements for this year.

The registration fee of \$170 for members of the American College of Allergists and \$190 for non members includes three luncheons and all coffee breaks. Additional luncheon tickets may be purchased at the registration desk. Your committee has arranged special fares from almost every major city in the United States to Toronto, if you wish to fly. If you prefer to drive, the city is easily accessible by car. If you do drive a car from the United States, all you need is its registration. If you rent one in Toronto your American driver's license is sufficient.

You will find Toronto a stimulating, thrilling, fun-filled city for the entire family with shopping facilities of an international inland seaport and almost total freedom from street crime. Entertainment includes wonderful restaurants, night clubs, art treasures and historical museums. Ontario Place has 96 acres of music, movies, park land, clowns, waterplay and relaxation. The Canada National Tower (the world's tallest structure) standing at 1,815 feet tall, almost twice as tall as the Eifel Tower, offers a revolving restaurant

at the 1,150 level and two observation decks at the 1,500 foot level, with a potential view of 100 miles. Just a few blocks east of downtown Toronto is the St. Lawrence Market Area built in 1844. Neaby, on King Street, is St. James Cathedral, built in 1853.






